Through this board work, she advocates and fosters a sense of community for Latinx-identifying students, LGBTQ students, and their allies by organizing academic and professional programming and social, cultural, and service events.

Patterson has also performed Pro Bono work with If/When/How: Lawyering for Reproductive Justice, a non-profit organization dedicated to transforming the law and policy landscape, so all people have the power to define, create, and sustain their families, and to actualize sexual and reproductive wellbeing on their own terms.

Patterson seeks to become a corporate transactional lawyer with a specialization in East Asia.

The mission of **Flaster Greenberg’s Mentor Program** is to provide summer associates with an opportunity to gain real-world experience working with the firm’s attorneys, staff, and clients, and to get a feel for what it is like as a first-year associate at Flaster Greenberg.

The **PDLG Fellows Program** provides diverse students completing their first year of law school with the opportunity to be considered for summer law jobs with PDLG members. This program is open to diverse law students - those who have overcome significant and uncommon obstacles in the pursuit of a legal career, come from a disadvantaged background or come from a background, or are part of a group that is underrepresented in the Philadelphia legal community. After going through a rigorous application and interview process, twelve students work as summer associates/clerks at twelve PDLG employers.
