Bill represents clients in all areas of Chapter 7 and Chapter 11 bankruptcy proceedings, creditor's rights, and corporate liquidations. In addition, he counsels debtors on the advantages and disadvantages of Chapter 11 and the rights and remedies of creditors and unsecured creditors' committees in the Chapter 11 process.
