REPRESENTATIVE MATTERS

- Third-party plaintiffs' counsel in CERCLA litigation filed against hundreds of defendants in the Helen Kramer Landfill, and Berks Landfill matters, each of which involved claims exceeding \$100 million dollars
- Originated third-party litigation under CERCLA in U.S. v. Price and its companion private party civil damages action bringing claims against hundreds of parties
- Through a series of numerous public meetings before the Improvement Authority and Board of Chosen Freeholders, and facing broad-based and contentious public opposition, obtained approval by a vote of 4 to 3 for the inclusion of a client's activities into the County Waste Management Plan, which approval was required by the NJDEP for the continuation of the client's business
- As the result of trial under the Open Public Records Act, obtained over 22,000 pages of documents that had previously not been identified and were improperly withheld by a municipality concerning its energy-related activities, and was awarded \$190,000 from the municipality for legal expenses incurred by the client as the result of the need to bring the action and trial to obtain the documents
- Obtained the reversal of a local zoning board's decision that was shown to be so politically motivated that the Appellate Division, upon review, upheld the reversal by the trial judge without any remand to the zoning board for further consideration

- Obtained the delisting of a previously registered dam from oversight and regulation by the NJDEP
- Through litigation, prevented the NJDEP's efforts to withhold approvals for the sale of a shipyard to new ownership, and obtained court approval for the sale by the shipyard's court-appointed receiver
- Spearheaded litigation that ultimately required the owner of property to complete the contract for the sale of property to a client; the owner had attempted to avoid the sale by delaying and not diligently pursuing its efforts to obtain ISRA approval from the NJDEP, which ultimately was obtained through the firm's efforts
- Successfully defended a multimillion-dollar claim by a national tenant that the client-owner of a shopping center had failed to deliver a 50,000-square-foot space free of asbestos
- In defense of a claim for which the client was accountable under the New Jersey Spill Act for the cost of 642 hookups to a public water supply system, determined that seven different plumes from seven different sources were responsible for the contamination of the previously private drinking water wells on the properties requiring the hookups; the DEP ultimately conceded that the client was accountable for less than ten percent of the number of public hookups required
