Mr. Brogan served as a director on the Board of Directors of the National Academy of Elder Law Attorneys (NAELA). He also served as chapter president of NJNAELA. Mr. Brogan was chair of the Elder and Disability Law Section of the New Jersey State Bar Association. He is a member of the Council of Advanced Practitioners (CAP), an invitation-only council comprised of innovators in the profession guiding the future of elder and special needs law. Mr. Brogan served as chair of the Ocean County Bar Association's Elder Law Committee. He is admitted to practice in the Superior courts of New Jersey, the Federal District Court of New Jersey, and the United States Third Circuit Court of Appeals. Mr. Brogan has been selected for inclusion in *Super Lawyers Magazine's* 2008 through 2016 editions, and has received an AV Preeminent Peer Review rating from Martindale-Hubbell. He serves on the Public Policy Steering Committee of NAELA and was selected by the NAELA president to chair the ABLE Act Task Force. The New Jersey State Bar Association has twice awarded him the Legislative Service Award for his lobbying efforts in the fields of elder law and special needs. He was an adjunct professor of Law at the Georgetown University Law Center, and is presently enrolled in the LL.M in taxation graduate tax program at Villanova Law School. He regularly lectures to other attorneys at the state and national level regarding Medicaid planning, planning for people with special needs, and the policy impact of healthcare issues on seniors and those with special needs. He has lobbied for positive legislative and regulatory developments on behalf of seniors and those with special needs at the state, congressional and presidential level.
