Worse yet, according to a 2018 report by the American Lung Association, in certain areas air pollution in New Jersey is so bad it could be dangerous to your health to breathe, and New Jersey's air continues to be among the most polluted in the nation, with a large swath of the state receiving failing grades for smog.
